

## WEDDING PHOTOGRAPHY CONTRACT

The undersigned (hereafter referred to as the clients) agree to contract the services of William O'Connell of Bill O'Connell Photography or his designee (hereafter referred to as the photographer) according to the following terms:

The clients contract for the services of the photographer for the date and times specified in the attached schedule. The clients agree to pay for said services in the following manner:

A \$100 non-refundable deposit shall be paid at time of signing of the contract. This deposit will reserve and secure the photographer's services for the date and times specified. In the event the clients makes changes to the date and/or times specified, the photographer pledges to make a good faith effort to accommodate the changes, but is not required to cancel any other contracts to do so. The clients further agree to pay an additional 50% of the contract price no later than 2 weeks prior to the wedding date, and that any remaining balance due on this contract will be paid on or before the date and time of the date of service of this contract (the wedding date). If, at any time prior to two (2) weeks prior to the date of service of this contract, the clients wish to cancel said contract, any monies paid to the photographer over and above the non-refundable deposit shall be refunded to the clients in a timely manner. If clients cancel within two (2) weeks of the service date, clients agree to pay an additional 10% of contract total as a cancellation charge, which shall be deducted from any refund due clients.

The photographer agrees to have the personnel required by this contract at the place and time specified below, ready to perform the services agreed to, unless delay is caused by circumstances beyond his control. All attempts to arrive prior to the specified time(s) will be made. The photographer further agrees to provide all photographs and other products or services requested within sixty (60) days after the date of service, unless other mutually agreeable arrangements are made. Photographer further agrees to make additional prints and other products available to clients for purchase. Prices for additional products are set according to the photographer's price list in effect at time of ordering. Current prices are attached to this contract. The photographer agrees to keep all film, negatives and/or digital files from this assignment for a minimum of five (5) years following the wedding date in a commercially acceptable safe manner. In the rare unforeseeable event that these materials are destroyed or damaged beyond use, the photographer shall not be held liable for damages. No other terms or conditions apply to this contract unless agreed to in writing by photographer and clients.
